SOUTH SUDAN GENERAL MEDICAL COUNCIL GENERAL MEDICAL COUNCIL PROVISIONAL ORDER ,2014.

Conditions and Guidelines for Registration (Section: 32)

- A. Requirements of Provisional /Preliminary Registration of Medical Doctors, vDentists and Pharmacists Graduates of South Sudan medical colleges
 - 1. Copies of academic qualifications signed and authenticated by the dean of college and Academic Affairs Secretary of the university
 - 2. Identification documents (Personal Identity Card or Passport)
 - 3. Four (4) Passport Photographs
 - 4. Completion of the registration form
 - 5. Pay the registration fees after fulfillment of registration requirements
- B. Requirements of Permanent Registration of Medical Doctors, Dentists and Pharmacists – Graduates of South Sudan medical colleges
 - 1. Successful completion of the medical practice examination of the South Sudan General Medical Council
 - 2. Original Copy of Certificate of Internship
 - 3. Original Certificate of Provisional Registration of Doctors, Dentists and Pharmacists (as applicable)
 - 4. Identification documents (Personal Identity Card or Passport)
 - 5. Four(4) Passport Photographs
 - 6. Completion of the registration form
 - 7. Pay the registration fees after fulfillment of registration requirements

C. Requirements of Provisional Registration of Medical Doctors, Dentists and Pharmacist – Graduates of Non-South Sudan medical colleges

- 1. Original academic certificates (authenticated from the relevant specialized authorities)
- 2. Original academic transcripts (authenticated form the relevant specialized authorities)
- 3. Accreditation of the academic certificates by the Ministry of Higher Education
- 4. Copies of English translation of the academic certificates in case the copies are issued in other languages
- 5. A copy of the successful secondary school certificate or equivalent





- 6. Identification documents (Personal Identity card or Passport)
- 7. Four (4) Passport Photographs
- 8. Completion of the registration form
- 9. Sit and pass the required examination (or as directed by the SSGMC)
- 10. Pay the registration fees after fulfillment of registration requirements

For South Sudanese and Foreigners who have graduated from Medical College and practiced in a foreign country in addition to the above they require to have:

- 11. Certified and attested certificate of registration in country in which he or she was qualified and practicing before applying for registration in South Sudan:
- 12. Certified and attested evidence of experience or training issued by the country where he or she was practicing before applying for registration in South Sudan.
- 13. Certified and attested certificate of good standing from the registration authority of the country in which he or she was practicing before applying for registration in South Sudan.

D. Requirements of Provisional Registration of Specialists

- 1. Original academic certificates (authenticated from the relevant specialized authorities)
- 2. Original specialist academic transcripts (authenticated from the relevant specialized authorities)
- 3. Accreditation of the specialists academic certificates by the Ministry of Higher Education
- 4. Authenticated copies of English translation of the academic certificates in case the copies are issued in other languages
- 5. Certificate of Permanent Registration
- 6. Identification documents (Personal Identity card or Passport)
- 7. Four(4) Passport Photographs
- 8. Completion of the registration form
- 9. Pay the registration fees after fulfillment of registration requirements

E. Requirements of Full Registration of Specialists

- 1. Certificate of Provisional Registration of Specialist
- 2. Certificate of Completion of Assessment
- 3. Identification documents (Personal Identity card or Passport)
- 4. Four(4) Passport Photographs
- 5. Completion of the registration form
- 6. Pay the registration fees after fulfillment of registration requirements
- 7. For Specialists who have graduated and worked in other countries ,in addition to the above the same conditions as in **C**, **11,12** and **13** also apply.





F. Requirements of Provisional Registration of Non-Sudanese Professionals Coming to Work in South Sudan

- 1. Original academic qualifications signed and authenticated by the dean of college and Academic Affairs Secretary of the university or institution
- 2. Authenticated copies of English translation of the academic and transcripts certificates in case the copies are issued in other languages
- 3. Certified and attested certificate of registration in country in which he or she was qualified and practicing before applying for registration in South Sudan:
- 4. Certified and attested evidence of experience/Internship and training issued by the country where he or she was practicing before applying for registration in South Sudan.
- 5. Certified and attested certificate of good standing from the registration authority of the country in which he or she was practicing before applying for registration in South Sudan
- 6. Curriculum vitae
- 7. Letter from the employer in South Sudan be it government, NGO or private sectors: registration will only be given for employment applied for and not transferable without approval of the Council
- 8. Identification documents (Passport)
- 9. Four(4) Passport Photographs
- 10. Completion of the registration form
- 11. Pay the registration fees after fulfillment of registration requirements
- 12. Certificate will have a three (3) months probation period
